SECTION 4: First aid measures

4.1. Description of first aid measures

- Inhalation: Remove victim to uncontaminated area wearing self-contained breathing apparatus. Keep victim warm and rested. Call a doctor. Perform cardiopulmonary resuscitation if breathing stopped.
- Skin contact: In case of frostbite spray with water for at least 15 minutes. Apply a sterile dressing. Obtain medical assistance.
- Eye contact: Immediately flush eyes thoroughly with water for at least 15 minutes.
- Ingestion: Ingestion is not considered a potential route of exposure.

5.3. Advice for firefighters

Specific methods:

Use fire control measures appropriate for the surrounding fire.
Exposure to fire and heat radiation may cause gas receptacles to rupture. Cool endangered receptacles with water spray jet from a protected position. Prevent water used in emergency cases from entering sewers and drainage systems.
If possible, stop flow of product.
Use water spray or fog to knock down fire fumes if possible.
Move containers away from the fire area if this can be done without risk.

SECTION 7: Handling and storage

7.1. Precautions for safe handling:

Safe use of the product:


The product must be handled in accordance with good industrial hygiene and safety procedures.
Only experienced and properly instructed persons should handle gases under pressure.
Consider pressure relief device(s) in gas installations.
Ensure the complete gas system was (or is regularly) checked for leaks before use.
Do not smoke while handling product.
Use only properly specified equipment which is suitable for this product, its supply pressure and temperature.
Contact your gas supplier if in doubt.
Avoid suck back of water, acid and alkalis.
Do not breathe gas.
Avoid release of product into atmosphere.
Containers, which contain or have contained flammable or explosive substances must not be inerted with liquid carbon dioxide.
Potential production of solid CO₂ particles must be ruled out.
In order to rule out potential electrostatic discharge production, the system must be adequately grounded.

Safe handling of the gas receptacle:

Refer to supplier's container handling instructions.
Do not allow backfeed into the container.
Protect cylinders from physical damage;
do not drag, roll, slide or drop.
Never attempt to repair or modify container valves or safety relief devices.
Damaged valves should be reported immediately to the supplier.
Keep container valve outlets clean and free from contaminants particularly oil and water.
Replace valve outlet caps or plugs and container caps where supplied as soon as container is disconnected from equipment.
Close container valve after each use and when empty, even if still connected to equipment.

Never attempt to transfer gases from one cylinder/container to another.
Never use direct flame or electrical heating devices to raise the pressure of a container.
Do not remove or deface the engraving provided by the supplier for the identification of the cylinder contents.
Suck back of water into the container must be prevented.

8.2. Exposure controls:

8.2.1. Appropriate engineering controls:

Provide adequate general and local exhaust ventilation.
Systems under pressure should be regularly checked for leakages.
Ensure exposure is below occupational exposure limits (where available).

Acute toxicity:	Unlike simple asphyxiants, carbon dioxide has the ability to cause death even when normal oxygen levels (20-21%) are maintained. 5% CO ₂ has been found to act synergistically to increase the toxicity of certain other gases (CO, NO ₂). CO ₂ has been shown to enhance the production of carboxy- or methaemoglobin by these gases possibly due to carbon dioxide's stimulatory effects on the respiratory and circulatory systems. 
